

## Release and Waiver of Liability

This Release and Waiver of Liability (the "Release") is executed on this \_\_\_\_ day of \_\_\_\_, 20 \_\_, by the minor volunteer and his/her legal guardian in favor of The Bellaire Little League, Inc a nonprofit corporation organized and existing under the laws of the State of Texas and its directors, officers, and agents (collectively, "BLL").

The Minor \_\_\_\_\_, desires to work as a volunteer for BLL and engage in the activities related to being a volunteer. I, the Minor's parent or legal guardian ("Guardian"), hereby give my consent for Minor's work in connection with BLL and freely and voluntarily execute this Release. Guardian and Minor agree and understand that Minor must comply with the rules and regulations established from time to time by BLL and that failure to do so may result in the Minor's removal as a volunteer. Such rules include, but are not limited to, adherence to the BLL standards of conduct imposed on parents and players and meeting high ethical standards.

**Waiver and Release.** The Guardian and Minor release and forever discharge and hold harmless BLL and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the Minor's work in connection with BLL. The Guardian & Minor understand and acknowledge that this Release discharges BLL from any liability or claim that Guardian and/or Minor may have against BLL, including with respect to bodily injury, personal injury, illness, death, or property damage that may result from Minor's work in connection with BLL.

**Insurance.** The Guardian and Minor agree that Minor is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Minor's work in connection with BLL and expressly waive any claim for compensation or liability on the part of BLL beyond what may be offered freely by BLL in the event of such injury or medical expense.

**Benefits.** The Guardian and Minor agree that Minor is a volunteer, not an employee of BLL and that BLL will not provide any benefits traditionally associated with employment to Minor.

**Assumption of Risk.** The Guardian is aware of the nature of the activities to be performed by the Minor and understands that in the Minor's work in connection with BLL a risk of injury exists. Guardian agrees that the Minor's work in connection with BLL is to be performed at Minor's risk and hereby expressly assumes responsibility for the risk of injury or harm to Minor in these activities.

**Photographic Release.** As the guardian of said minor I grant and convey to BLL all right, title, and interest in all photographic images and video or audio recordings made by BLL during the minor's work with BLL. Guardian and Minor also understand and agree that Minor may be recorded on security cameras while working in connection with BLL.

I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall no otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
